## EXHIBITOR PRICING

### **Exhibit Space Fees**

Space Only: \$60 per sq. ft.

Shell Scheme Package: \$70 per sq. ft.

ATCA members receive a 10 percent discount off their exhibit space fees.\*

Space only is for exhibitors with custom designed booths and only need to rent the actual space.

Shell Scheme Package requires minimum of 100 sq. ft. (minimum 10ft. by 10ft.) of exhibit space.

Fully furnished shell scheme includes: exhibit space, draped walls, carpeting, sign with company name, one (1) table, two (2) chairs, (1) wastebasket, (1) 120 electrical duplex outlet. ALL exhibitors, including Space Only, Shell Scheme, and Co-Exhibitors will receive complimentary badge reading lead retrieval tools.

\* Membership must be in good standing at the time of contract submission and during Exhibition dates.

## **Registration Fees**

#### **Primary Exhibitor Registration Fee: \$375**

This is a non-refundable flat fee, independent of booth size, that is charged to primary exhibitors.

A **Primary Exhibitor** is the exhibiting company that is named on the contract for the rental of the physical exhibit space and has control over the rented exhibit space.

#### Co-Exhibitor (Sharing) Registration Fee: \$1,000

This is a non-refundable flat fee, independent of booth size, that is charged to Co-Exhibitors.

A **Co-Exhibitor** is an exhibiting company that is sharing rented exhibit space with a Primary Exhibitor and has completed the Co-Exhibitor contract.

**Exhibitor Insurance:** Liability insurance with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate is required in order to exhibit at ATCA Global. This insurance must be in force during the ATCA Global dates October 30 - November 3, 2023, naming as additional insured: **Air Traffic Control Association (ATCA)** and **Walter E. Washington Convention Center.** No additional insurance is required for your participation in ATCA Global.

**Credit Card Processing Fee:** A non-refundable fee of 3.75 percent will be applied to all fees paid by credit card. This fee will not apply to bank transfers or check payments.

**Allocation of Exhibition Space:** We encourage exhibitors to visit the ATCA Global booth onsite to meet with ATCA Global staff and plan and reserve your exhibit space for 2024.

#### **Additional Space Options**

Multilevel Booths (ground floor of booth must be a minimum of 600 sq. feet)

For multilevel booths, add 10 percent to the regular booth price for the area built on the top floor. ATCA Global must approve all custom booths. Booth plans should indicate the name of the event and booth number, specify maximum number of occupants allowed, and have a structural engineer's stamp certifying that the platforms can bear the maximum occupant load. Additional safety elements may be required upon Fire Marshal review.

# **Cancellation/Space Reduction**

Registration Fee: Non-Refundable

Booth space rental fee refund schedule:

75 percent refund with receipt of written cancellation by July 1, 2023

50 percent refund with receipt of written cancellation by August 1, 2023

25 percent refund with receipt of written cancellation by September 1, 2023

No refunds/Credits after September 1, 2023, will be made for any booth cancellations, booth space reduction or booth type changes.

#### **Payment Schedule**

All fees are due in full within 30 days of receipt of invoice. Should a contract be received less than 30 days before Exhibition setup start dates, full payment must be included with contract.

#### **Allocation of Exhibition Space**

All ATCA Global Exhibitors who were contracted in 2022 will receive priority placement in the Exhibition Hall for ATCA Global 2023 as long as their contracts are received by January 31, 2023. After January 31, 2023, all exhibitor contracts will be placed on a first-come, first-served basis. A completed Exhibitor Contract must be received before placement in the Hall can occur.

## **Priority Placement**

- All ATCA Global Exhibitors have the right of first refusal of current booth space upon ATCA's receipt of Exhibitor Space Contract by January 31, 2023.
- Exhibitors who wish to move or change/increase in size will be placed on the following criteria.
   Priority is given first to:
  - i. ATCA corporate members.
  - ii. Then to exhibitor's company spend at ATCA Global the previous year. (exhibit space, sponsorship, advertising fees). If spend is equal, then priority is given in order of contract receipt.
  - iii. After January 31, 2023, priority placement ends and all contracts received will be now placed on a first-come, first-served basis.



# ATCA GLOBAL EXHIBITORS INFORMATION (continued)

#### **Sharing Exhibit Space**

Exhibit space may be shared. There will be one primary exhibitor who controls the exhibit space. The Primary Exhibitor must complete the contract for exhibit space and be assigned a booth number before a sharing exhibitor (co-exhibitor) may submit a contract to share. Sharing Exhibitors are required to complete the Co-Exhibitor Form and pay the appropriate fee. You will receive a confirmation that we have received your Co-Exhibition Form.

### **Exhibitor Badges**

All badged exhibitor staffers are required to be registered and will receive a badge displaying the exhibiting company name. Exhibitors are allowed to register a maximum of 5 exhibit staff for every 100 sq. feet of exhibit space rental. For every 100 sq. feet of exhibit space rental, exhibitors will receive 2 complimentary full access pass to all programming and may purchase an additional 3 exhibitor staff registration with full access to all programming for \$185 each.

An exhibitor registration form will be included in the ATCA Global 2023 Exhibitor's Manual or you may register your staff online. Registration will open by summer of 2023.

Booth setup-only badges will be provided at no additional charge.

# Contract Submittal and Booth Confirmation Process


Once you have completed all the required fields and have clicked the submit button, you will receive an email confirmation from ATCA Global acknowledging receipt of your contract. Your contract will be reviewed by ATCA Global staff who will assign your booth a number. Once your booth is assigned, you will receive a second email confirming your booth assignment and providing your login credentials and instructions for accessing ATCA Global's Exhibitor Zone.


